1. **STRICTLY:** NO STEEL, WOODEN, PLASTIC OR ANY OTHER FORM OF PLANTER OR TRINKET HOLDER MAY BE ERECTED AT ANY LAWN GRAVE OR ASH GRAVE.

DMP reserves the right to and will remove any planters or other installations that do not meet the above requirements without notice.

Only standard DMP vases, which can be purchased at the office, are to be used.

2. DMP cannot guarantee the safety of your precious items so it is **highly advised** that **trinkets/ornaments are NOT placed on or around any graves.** Placing of any trinkets/ornaments will be at the owner's own risk and need to be limited to what can be properly secured onto the surface of the tombstone or plaque.

DMP reserves the right to and will remove trinkets/ornaments that do not meet the above requirements without notice.

3. Families agree to maintain and clean their tombstones and plaques. Due to the use of borehole water, a residue can build up on the surface of tombstones and plaques over time. See "Fact Sheet - Granite" attached to the Park Rules for more information.
4. Contact the office should you require an extra vase to be placed on the grave. Any non-standard vase found on the grave will be removed without notice. Should you find your grave without a vase, please DO NOT remove any vases from ANY OTHER grave as these belong to them. Contact the office to discuss the matter.
5. Watering of plants and flowers in DMP vases is the sole responsibility of the grave owner and family.
6. To have a bench placed anywhere in the park, approval must first be obtained from DMP and the placing will only be carried out by DMP staff.
7. Flowers and wreaths placed on the grave at the time of the funeral, will be removed as soon as they have withered.
